# Q&A

Q: Will moms have the option of purchasing more than one ticket if she or the dad already have a twoor foursome to participate?

A: Yes. Indicate the number of additional tickets on the Allocation Form. You will be invoiced for the additional tickets, subject to availability.

Q: In addition to the golfer's name, is there a way to indicate moms that are paying the assessment but do not plan to participate?

A: Yes. The Allocation Form asks & collects Mother's intentions

Q. If there is a non-golfer's activity/day party, can the \$250 assessment go towards a ticket to this activity if the mom does not have a golfer?

A: Yes. If you don't have a golfer & you want to attend the Day Party, Assessment = Two \$125 Day Party Tickets (Mother and Plus One) And the player slot will be resold.

\*\*\*\*\*\*However, if you do have a golfer, we prefer you allocate your assessment to your golfer and be invoiced Day Party tickets. This ensures we meet our contracted minimum player quantity of 72.



# Mother Member Assessment/Ticket Allocation & Player Registration Form

Your Foundation Assessment includes one Player ticket for the event. We have 61 player slots reserved for Mother Member tickets. In order to understand whether a Mother's ticket can be resold, we need to know the following:

- 1. The Name & Contact Information of the Player using your ticket.
- 2. If you do not have a player for your ticket, would you be interested in attending the Day Party ( Your assessment will go towards two (2) Day Party tickets (\$125 each) and the player slot will be resold)
- 3. You do not have a player for your ticket, neither you or a guest will be attending the Day Party, the Committee will resell your ticket
- 4. Would you be interested in purchasing additional Player tickets (@\$250 per player)
- 5. Would you be interested in purchasing additional Day Party tickets (@\$125 per attendee)


